REACH and RoHS declaration of conformity

Hereby NOVA Werke AG declares that all our products are REACH and RoHS-compliant. On March 31, 2015, the EU Commission published directive 2015/863/EU and is valid from July. 22nd 2019. The directive Regulates the restriction of the use of certain hazardous substances in electrical and electronic equipment. According to Article 33 of REACH, the manufacturer has the obligation to provide sufficient information to the Consumer/recipient of the article if Substances of Very High Concern (SVHC) of candidate list are contained in its Products in a concentration above 0.1% weight by weight (w/w). Compared to the currently valid directive 2011/65/EU, the list in Annex II is extended by four phthalates. According to the directive 2015/863/EU (Annex II), The Following substances are subject to restrictions:

- Diisobutylphthalat (DIBP) (0.1 %) (added in 2015)
- Ozone depleting (CFC-sustainably) substances

Are used and that for the raw materials the limit values determined in the directives listed in the Following do not exceed (confirmation by the raw materials suppliers). We therefore consider the Following directives as fulfilled:
